**TERMS & CONDITIONS**

The **FIRST PARTY** will agree to appoint the **SECOND PARTY** as its legal representative in **Nepal** for the purpose of supplying manpower (Nepalese workers) for his company and will provide all the required documents such as **Power of Attorney, Demand Letter** and **Employment Contract** for the selected workers
4. The **SECOND PARTY** will be completely responsible to bring selected manpower from Nepal to the **Kingdom of Saudi Arabia** within three months of demand attestation from the Embassy. During the probation period if any of the workers is found to be medically unfit, refused to work and got homesick, Second Party will bear all expenses for repatriating the said workers back to his/her home county and make replacement with free of charges
5. The **FIRST PARTY** shall make arrangements to make visa for all the selected workers
6. The **FIRST PARTY** will provide all the facilities to all the selected workers incorporated in the Demand Letter and as per the prevailing Labour Law of the Kingdom of Saudi Arabia
7. In case of death of the worker during the contract period, the First Party will repatriate the remains of the deceased at the expense of the .company. Both in the case of death and injury, compensation shall be paid according to the Labour Law of the host country
